As a baseline, most our shared priorities — investing in public education including increasing the resources in our classrooms, increasing the compensation, health care and retirement security for teachers and hourly school workers, increasing the supports

for students including more counselors and mental health workers, investing in higher education pipelines to increase the teachers of color and indigenous teachers in our classrooms, and eliminating the special education cross-subsidy, to name a few — require a budget that raises additional progressive revenue and allocates it to our education priorities.

I am committed to our shared goal of increasing progressive revenue and investments to strengthen public education. That requires allocating our budget in a way that centers the needs of students and communities, starting by prioritizing efforts that reduce the disparities and opportunity gaps for BIPOC kids and communities. For our kids to succeed, they need talented, experienced educators who are supported and invested in at every stage of their career and development — from recruitment to retirement. I will work to support teachers at all stages of their career. That starts by attracting teachers to a profession where they are fairly compensated, respected, and provided the training, support and resources to succeed. We need to retain teachers by ensuring that they have power on the job, manageable class sizes, wrap around support for students, and retirement security when they are finished with their career.

As someone without expertise, or any personal experience with having a pension, as we discuss reform options for TRA, I will listen closely and learn from educators at all stages of their career, including prospective teachers. I will work to ensure that reform efforts support our shared values of strengthening public education, ensuring our kids get a world-class education, ensuring family-supporting compensation and retirement security for our educators, and supporting our educators at every stage of their career in public education.

Striking worker unemployment insurance, expansions of PELRA, and increasing the enforcement of our labor laws are all policies that I'm proud to support.

I deeply believe in the power of unions to create worker power and prosperity in the workplace, in our economy and in our democracy. MFT members are the teachers and educators that are educating, advocating and supporting our public school students, families and communities and I am ready and enthusiastic to work with you to ensure every kid in Minnesota gets a great education. And I will support, organize and work alongside MFT and other unions to build power and public support for a bold and robust agenda that invests in our kids, our communities, our schools and our environment.

Your role as a legislator

Have you visited a public school in your district in the past year? If so, which one? What were your observations from your visit? How will that experience inform your work as a legislator? If not, when did you last visit a school? Would you like us to help arrange a visit?

Yes. I've spent time in Justice Page Middle School and Washburn High School. In both schools, I observed a strong and talented community of educators who are deeply committed to educating, supporting, and caring for the students in their school. I heard about the successes of reading interventions, universal school lunch, and specialized curriculum that teachers were developing with their student body in mind. I also heard about issues of absenteeism, of workforce shortages that left the administration and teachers to scramble for subs, of the increases of new to country students, and the urgent need for increased mental health support for students and educators alike. I'm also eager to visit the schools in my district and eager and ready to work with you and your members to lead on public education at the Capitol.

What have you done to become informed on issues relating to public education? What organizations and individuals do you go to for your information?

I listen and learn from the teachers, educators, support staff and parents in my district and across the state. When I have questions and seek guidance, I've asked community members, union leadership, teachers, school workers, principles, and public school parents for their perspective.

Public education is incredibly important to me and I've been personally connected to public school teachers and educators, students and parents my whole life. On issues relating to public education, I go to MFT, Education Minnesota and SEIU Local 284 for information, guidance and a trusted perspective. Throughout my career and advocacy work, I've often consulted and been advised by leaders and organizers in the field I know and trust including Mary Cathryn Ricker, Rep. In addition to the outreach to folks who are already politically active in my district, with your support, I'd love to continuing building relationships with MFT members who live in the district. Hearing their stories, learning more about the work they do, and their values and vision for our district and our state will help me understand how we can better serve both members and the public.

Whether it is finally ensuring hourly school workers have access to unemployment insurance, or fighting to increase funding for schools, I am proud of the work we've done together in the legislature in the last four years, and I look forwarding to continuing working in partnership to make our shared vision of strong, inclusive public education a reality. And partnership means that when we disagree or don't share the same perspective – I will communicate, listen and engage with you and your members on where we can find common ground and shared priorities. A trusting relationship requires good two-way communication even when we don't agree.

If elected/reelected, how will you balance competing priorities that might exist between Education Minnesota and other education groups?

We need to start by asserting an aligned set of bold and progressive policy priorities and reject a scarcity mentality that often leads us to negotiate against ourselves or think too small. While I will always do my homework, I am very grounded in the people who do the work and the communities impacted by the policy decisions — I start from the experiences and perspectives of the educators, school workers, students, and families in my community.

I believe deeply that we are stronger together and we can work to set our priorities together — electeds, Education Minnesota, other unions and progressive advocacy organizations. And it must all start with the baseline that we will raise the progressive revenue we need to invest in fully funding our schools, advancing racial equity in our schools and communities, protecting the power of educators and support staff to do their jobs, and center the needs of students and communities. My background is in working with labor organizations, progressive organizations and progressive candidates to build coalitions and aligned agendas and I think that orientation serve me well in this regard.
